

# PHILOMATH FROLIC & RODEO, INC.

## Queen Rules of Conduct

The Philomath Frolic & Rodeo Queen and participants in the Queen Try-Out are expected to adhere to the following as closely as is reasonably possible. Any deviations should be discussed with the Miss PF&R Advisor(s) and/or Court Committee.

1. The Queen is a “Representative” of the Philomath Frolic & Rodeo Inc. It is the duty and obligation of any Queen to portray the highest of moral standards and show the ideals of womanhood. Appearance and personality shall reflect being ‘**on the job**’ at all times. The Queen must portray good sportsmanship to other court members, committee members and people she encounters, setting an example above reproach.
2. The Queen is responsible for having her horse, pickup and horse trailer ready at all times. Dependence on other transportation for yourself or your horse is not acceptable. Copy of vehicle and horse trailer registration as well as proof of vehicle insurance is required for Tryout and reign. The horse should be shod, fit and groomed, and ready to go at all times.
3. Pregnancy during reign is cause for automatic dismissal.
4. The Queen can only reign once. *(See Queen Guidelines numbers 4 and 12 for possible exception.)*
5. Any Queen under the age of 21 shall not consume alcohol or controlled substance of any kind during reign. This includes *all tobacco products*. Proof of medically prescribed substances will be required.
6. Any Queen age 21 or older shall not consume alcohol or controlled substances prior to or during a scheduled appearance, nor while in official attire following appearance. This includes *all tobacco products*. Proof of medically prescribed substances will be required.
7. The Queen shall abide by instructions given by Miss PF&R Advisor(s) or designee. If a decision not to comply results in injury or damage to people or property, the Queen accepts all responsibility as per the signed Waiver Agreement.
8. Failure to comply with any of the above rules may result in immediate forfeiture of title. All attire, crown, buckle or other court items, etc. *(as listed in Queen Guidelines numbers 14 and 15)* will immediately be returned *in good condition* to the Miss PF&R Advisor(s) (or designee) of the Philomath Frolic & Rodeo, Inc. The Miss PF&R Advisor(s) (or designee) and Executive Board shall have final authority over non-compliance of above stated rules.

**I have read, understood and agree to abide by the Queen Rules of Conduct and Queen Guidelines as stated on both sides of this document. If selected as Queen, these rules and guidelines will remain in effect throughout my reign.**
